Scope of Work

The Scope of Work is approximately 1400m2 of existing floor area described generally as the following, to be awarded as a single contract:

Demolish existing walls as indicated. Some minor addition and infill work will also be required. Strip back existing floor finishes as indicated. Provide floor patch and levelling. Break open existing slab on grade for plumbing and structural requirements. Provide engineered temporary structural support (pinning) of building structure to allow for the installation of new foundation pads, columns and steel beam at enlarged opening as indicated. Provide plumbing services and electrical services as noted. Finish slab on grade where work has been completed. Construct new walls, complete with new hollow metal frames and wood doors. Install new sheet flooring as indicated. Patch and repair all damaged walls and ceilings, completely finish and paint all rooms. Install new LAT ceiling grid and lights in ceilings as indicated for new. Repair and relamp existing lighting as indicated. Provide all millwork and cabinetry as indicated. Significant Mechanical and Electrical requirements are also generally required throughout the affected areas.
