**Invitation**

Offers signed under seal, executed, and dated will be received by **St. Clair Catholic District School Board, 420 Creek Street, Wallaceburg, Ontario, for Asphalt & Drainage Upgrades to St. Vincent Catholic School, 9399 McNaughton Line E., R. R. #1, Chatham, Ontario until 2:00 p.m. local time, as indicated on the timeclock of the SCCDSB Reception, on March 13, 2012.**

**Scope of Work**

Project consists of the following work, to be awarded as a single contract:  
Milling and replacement of approximately 1,420 square yards of existing asphalt topping with new 1 1/2" HL3 Asphalt Topping on Tack Coat, complete with Related Work to install concrete pads and precast concrete parking bumpers.  
Revisions to existing Playground Drainage System  
Separate Price #1 is requested for replacing an additional 360 square yards of asphalt topping with new 1 1/2" HL3 Asphalt Topping on Tack Coat and related work.  
Separate Price #2 is requested for modifications to the existing entrance walkway.
