#### A. Special Education Report

Lisa Demers

- We must provide Special Education Report annually to the Ministry. It is posted on the Board website. It outlines the programs and services provided by the Board.
- Lisa Demers highlighted areas of the report as it is currently on the website (Checklist, Table of Contents, and Additional Information).
- Lisa connected the Information Items from this evenings meeting (below) and highlighted where they apply in the Special Education Report.

#### 6. INFORMATION ITEMS

A. Preschool Transitions

Janet Boyle

- Janet explained the Preschool Transition process practiced in our Board.
- "Planning Entry to School" is the resource document used to formulate the process currently in place.
- This year 16 preschool transition meetings were held in Sarnia-Lambton and 10 meetings in Chatham-Kent for children with moderate to high needs entering school in September 2014

#### B. Grade 8-9 Transitions

Lisa Thompson-Power

- This year there are approximately 185 students with an Individual Education Plan transitioning to secondary school.
- The grade 8-9 transition packages are prepared by the school team, the student and the parent/guardian. The packages are shared with the receiving high schools. The packages outline information regarding academic, physical, social, emotional and/or behavioural needs.
- If the student is leaving SCCDSB, parents are asked to sign consent so that the grade 8-9 transition package can be shared with the receiving school board.
- Upon receiving the transition packages, the receiving high schools arrange a spring transition
  meeting at the high school with the school team, the student, the parent/guardian and/or any
  community partners involved with the student.

#### C. Enhanced Transitions

Jennifer Morrow

- Students who require additional preparation for the transition to secondary school go through the enhanced transition process.
- A meeting is held with the school team, consultants and the parent/guardian early in the
  winter. Conversations are held regarding early transition days at the high school,
  transportation, anxieties about going to high school, programming, timetables, resource
  support, student services, supervision throughout the day if required, etc.
- This year approximately 26 enhanced transition meetings were held.

### D. Annual Accessibility Forum

Janet Boyle

- Each year the board seeks input from students for the board Accessibility Plan.
- 28 students attended the forum this year.
- Students provide input regarding any barriers to accessibility in their school. The board uses this information to formulate board's Accessibility Plan.
- This year's guest speaker was a former student, Dan Edwards, who presented for a portion
  of the morning. The remainder of the morning was spent engaged in activities simulating
  certain disabilities using the Diversity Kit.
- The Diversity Kits are available to build awareness about learning differences.

#### E. Diversity Awareness

Janet Boyle

• Janet led the group in diversity activities (Visual, Fine Motor and Auditory) similar to what was done at the Accessibility Forum, using the Diversity Kit materials.

### F. Teaching to Diversity - step two

Lisa Demers

- The Inclusive Educator Group from University of Western Ontario is hosting a second round of Teaching to Diversity on March 27, 2014. Lisa Demers, Jen Morrow and Lisa Thompson Power will attend and bring back the information to SEAC.
- A recommendation from the "Secondary Life Skills Review" was a trip to visit a fully inclusive secondary school. The scheduled visit had to be cancelled due to winter weather. In the spring, a group of secondary staff with Lisa Demers and Jen Morrow will visit the school to observe programming supports for students.

#### 7. REPORTS FROM THE BOARD

- Carol Bryden shared that the Board is working on strategic planning. There has been consultation with various groups throughout the system. The Director is collating the information which will be shared upon completion.
- The budget process will begin shortly. No meetings have been held yet. The Board has
  written the Minister requesting increased funding for special education to better reflect the
  needs.
- Mental Health update at UCC today, Clara Hughes was present to share in her bicycle
  journey across the country. She spoke of her own mental health issues and mental health
  issues in general. She was very well received by all who attended. She will also visit St.
  Patrick Catholic High School in Sarnia.
