#### **E. NEW BUSINESS**

1. SEAC Meeting Dates

Dr. F. Leddy

Dr. Leddy requested that the SEAC meeting on November 18, 2013 be rescheduled to November 25, 2013 due to a conflict in schedule.

Dr. Leddy emphasized the importance of having a quorum at SEAC meetings. He requested that if committee members are aware of a meeting that they are unable to attend, to please notify Alecia Atterbury, Administrative Assistant to Dr. Leddy ahead of time. Dr. Leddy asked if participants had a designated alternate to replace them in the event of their absence.

2. Special Education Administrators Report

L. Demers

Lisa Demers shared highlights from the Special Education and Student Services Report that was shared with the Administrators at the August 28<sup>th</sup> meeting. Areas of focus for the 2013-2014 school year include PPM 156, professional development and support in the area of Functional Behaviour Assessment (FBA), Mental Health, and the implementation of the recommendations from the Secondary Life Skills review of program and services.

## F. INFORMATION ITEMS

1. Mental Health Lead

L. Demers

Funding was made available through Ontario's Comprehensive Mental Health and Addictions Strategy, Ministry of Children and Youth Services. Beth Kuhn has been hired as the Mental Health Lead for the Board. Beth comes with an extensive background in mental health. As the Mental Health Lead, Beth will be responsible for coordinating, aligning and implementing a Board-level comprehensive student mental health and addictions strategy.

2. Eagle Rock Closure

L. Demers

At the end of June 2013, the Board received information on the closing of the Section 23 classroom (Eagle Rock) in Sarnia. There was no formal warning prior to the announcement. Service providers from the Ministries of Community and Social Services, Children and Youth Services, Health and Long-Term Care, Community Safety and Correctional Services, and Education provide a multi-disciplinary approach to meet the needs of children/youth requiring special services. The students will now receive education in London and Windsor.

3. Mental Health First Aid

L. Demers

During this past summer, there was an attempt to run a two-day training for classroom teachers, but due to insufficient numbers, the training was cancelled. There are plans to reschedule these sessions for this school year. Sharon Berry Ross and Tim Charrette will be the facilitators.

#### 4. New PRT Orientation

L. Thompson-Power

Three half-day training sessions were held for twelve new Program Resource Teachers in September. Topics included the IEP Engine, development of IEPs, SEA funding, the IPRC process, Board support teams and community support teams.

#### 5. Phonological Assessments

J. Boyle

The Speech-Language Pathologists will administer the phonological awareness screening to all SK students across the system during the month of October. This year there is funding available through "Learning for All" to provide release time for the Kindergarten teachers to meet with the Speech-Language Pathologist and the Program Resource Teacher. This will provide an opportunity for the team to collaboratively analyze the class profiles which can be used to program for all students from at-risk to advanced.

#### 6. PBS Expansion

R. Zarebski

One of the goals of the Special Education Department for this school year is to further implement the School Wide Positive Behaviour Support Model (PBS). The current schools continuing the program are St. Joseph, Chatham, Holy Family, Wallaceburg and St. Matthew, Sarnia. St. Joseph, Tilbury and St. Agnes, Chatham have requested a presentation to staff. St. Ursula, Chatham has expressed interest. There must be 80% support from the staff in order to proceed with the program.

## 7. Geneva Centre Summer Training

Twenty-one staff from SCCDSB, including Educational Assistants, Classroom Teachers, Administrators, Resource Teachers, Central Office staff (Autism/ABA Teams and Behaviour Support Team staff) attended the Summer Training Institute in August through the Geneva Centre for Autism. The one or two–day sessions included ASD in the Classroom, Functional Behaviour Assessments, and ASD and Mental Health. As well, 2 staff attended TEACCH training which is specific to the understanding/structuring and usage of Structured Learning.

## G. REPORTS FROM THE BOARD

The Board met for the first time in late August. The search continues for a new Director. Jim McKenzie is currently the Acting Director.

Effective September 2013 all Lambton County Catholic high school students are attending the current St. Patrick's campus on East Street during the construction of the new consolidated St. Patrick's Catholic High School at the St. Christopher site.
