A. Psycho-Educational Assessments

Laura Cutler Robbins

- The handout outlines Laura's role regarding psychoeducational assessments
- Laura shared the purpose of the assessment as well as the types of assessments provided to the board. There are standard psychoeducational assessments and diagnosis psychoeducational assessments provided.
- The assessments look at the different learning styles of students, academic testing (reading writing math, listening comprehension, etc.), processing skills, memory testing, and/or conceptual development (nonverbal processing).
- The assessments are standard, however, the reports are all unique based on the individual results of each student.
- Laura discussed the tests that she uses and what is involved in assessing students
- B. Pathway to Care and the Mental Well Being Framework

- Christine shared the SCCDSB Well-Being Pathway to Care handout.
- The focus of the work of the team (Child and Youth Workers and Social Workers) has changed and is outlined in the handout.

A. Tracking of Phonological Assessment

Janet Boyle

- Beginning September 26, 2016, the Speech-Language Pathologists will be administering the phonological awareness screening to all students across the district in Year 2 of the Kindergarten program.
- Grade 1 students considered to be "at risk" (based on last April's screening results) will be screened
 by the Program Resource Teacher in each school.
- The objectives of the screening are to assist teachers in identifying and tracking the development of early literacy skills to support student success and to provide the school team with very useful data to support programming.
- Currently the board is developing a program so that the data for each student can be tracked centrally, similar to EQAO results and other student data. This data will be available to Principals and Senior Administration.

B. Geneva Centre Program

Sara Vadovic

- The board has been provided 20 spaces for the opportunity to complete online courses for educators through Geneva Centre.
- The courses available are: Charting a Path to Success in Your Classroom: An Introductory Autism
 Certificate Course for Educators; Online Applied Behaviour Analysis Certificate Course for Educators;
 Online Special Topic for Educators: Supporting Children with ASD in an Inquiry and Play-Based

Learning Environment Using ABA Certificate Course; and ABA for Educators Level II: Practical Applications of Reinforcement and Prompting in the Classroom.

 We are going to recruit new and existing Program Resource Teachers and Classroom Teacher as well as the ASD team members.

C. Changes to Enrichment Programming

Lisa Thompson-Power

- There are an estimated 30 students in Sarnia Lambton and 28 students in Chatham Kent this year.
 Letters went home to parents in June inviting all of the students to the 2016-17 learning opportunities for enrichment.
- The students are in grades 4 through 8. New students are invited to attend based on their scores in the Canadian Test of Cognitive Skills (CTCS) an assessment administered to all grade 4 students in early spring.
- Enrichment opportunities will be held in the secondary schools St. Patrick's and UCC. Each group
 will come together on 4 occasions throughout the school year:
- The focus of the programming will be on Science, Technology, Math and/or the Arts
- The first sessions at St. Patrick's and UCC are on October 19th and October 21st. 2016.
- D. September 30th Professional Development Day for Educational Assistants

- The Educational Assistants will have the opportunity for training in two areas: BMS (Behaviour Management Systems) and Autism.
- All EAs who received the full training last year will receive the BMS half day refresher training.
- All EAs will work on the "Introduction to Autism Modules from Geneva Centre" a continuation of the module completion. EAs completed Modules 1-3 last Spring On September 30th Modules 4 – 6 will be completed. There are 12 modules in total.
