#### 7. INFORMATION ITEMS

A. Lexia Core Reading Program

**Brendan Deery** 

- The board has purchased this program for students who are not meeting benchmarks in reading. Five hundred licenses have been purchased. The initial focus will be on grade 2 students who have been identified as struggling readers by the school team and on students who have been IPRC'd as Communication: Learning Disability and are reading between a grade 1 to a grade 5 level.
- The program will enhance the work being done with students in reading. The program is webbased and can be accessed at home and at school.
- Training will be provided to all school administrators, gr. 2 teachers and program resource teachers on September 20 and 21, 2017.
- The grade 2 teacher and the program resource teacher will be responsible for implementing the program in the schools.
- B. 2017-18 Pilot to Improve School-Based Supports for Students with Autism

Spectrum Disorder Brendan Deery

- We are participating in a pilot project with the Ministry of Education to improve school based supports for students diagnosed with Autism Spectrum Disorders in elementary schools.
- It will target Educational Assistants who will receive training through the Geneva Centre for Autism with whom the Ministry of Education has partnered.
- Each board will receive a certain number of spots for participants based on the size of the board. We do not yet know how many spots we will be granted.
- It will take place at an elementary school site yet to be named.
- ABA practitioners from the community will come to the schools to work with the students.
- The pilot project will be governed by a provincial advisory team. The Ministry of Education is providing an external researcher to evaluate the implementation of the pilot.
