Georges P. Vanier School Important Notes

Adverse Weather

The closing of the school due to dangerous weather conditions will be announced on CFCO and CKSY Radio by 6:30a.m. Our school is located in ZONE 8. If classes are cancelled students are not to be sent to school. If the buses are to take the students home early the school will endeavor to contact parents by phone. It is very important that our school records are kept up to date at all times. If the buses are cancelled due to severe weather, there will be no a.m. or p.m. run. However, if buses are cancelled due to fog there will be a p.m. run.

Dress Code

In the past we have had a few concerns with the dress code of our students. It is the policy of the St. Clair Catholic District School Board that students adhere to the following guidelines in regards to dress:

- A) Students shall be dressed in a neat and respectful manner
- B) Students in all grades are allowed to wear shorts but no cut off shorts will be permitted. Hands at the side are the length needed. No short shorts.
- C) Students will not be allowed to wear clothing with inappropriate slogans or pictures on them. (inappropriate meaning anything implying smoking, drugs, sex, profanity, violence or other undesirable values)
- D) Students will not be allowed to wear bare midriff tops or halter tops. (No undergarments should be showing)



Health Canada Advisory Regarding Drawstrings for Children's Upper Outerwear

Health Canada advises that some children's clothing products can pose a danger. The products listed as potential hazards for children include upper outerwear in sizes newborn to 12 years that have drawstrings in the hood and neck area.

"Children's upper outerwear" means upper body clothing, such as jackets and sweatshirts, generally intended to be worn over clothing. Drawstrings on these garments can become caught on playground equipment, fences or other objects and result in strangulation; or, in the case of a vehicle, a child being dragged. Parents should ensure that purchases of children's clothing have alternative closures to drawstrings, including elastics, buttons, velcro or snaps.

Attendance and Safe Arrival

Poor school attendance and arriving late **for class will result in poor school progress and anxiety.** If your child is to be absent, in the interest of safety, please call and leave a message at Georges P.

Vanier 519-354-6550 before 8:00 am. Our school secretary will phone the parents of students whose absence is not reported. A pupil who arrives after the 8:30 bell is considered late and are asked to report to the office before heading to class.

If your child is sick and unable to complete the day to day requirements of school including going outside for recess, please keep them home until they are able or contact the teacher.



Breakfast Club

The date for our Breakfast club will be announced. This year as always students will need permission (understanding allergies and restrictions) but breakfast club will be a grab and go format. Items may include yogurt, muffin, cheese string etc. Students will take an item on the way to class after 8:15.

Keeping OUR SCHOOLS SAFE



The St. Clair Catholic District School Board has installed remotely controlled door locking systems, and intercoms, at all elementary schools.

With all protocols being put in place—we need parents to reach out to the school with a phone call. Parents and visitors are required to identify themselves at the door, and complete the COVID self assessment then sign in at the foyer table. All visitors must wear a medical mask when they enter the building. It is important to note that there may be times when our school secretary will be away from her desk for a moment and visitors may have to wait.

Alternatively, parents and visitors should consider the following:

- * Let us know if you want to pick your child up so that we can arrange to have him/her ready for you. Ideally, send a note to your child's teacher. We will have them ready.
- * Students who leave during the day will only be invited back when they are accompanied by a parent who has completed another COVID self assessment (attached at the end of the newsletter).
- * Most parent meetings will happen virtually to help eliminate extra people in our school.

PARKING

As you may have noticed, we have put out pylons in the parking lot and you have had to use the few spots in the front or surrounding streets. The safety of our students is paramount at all times. In the past parking along the school has led to much congestion and safety is a concern. Throughout the year, please continue to ONLY use those spots at the front and the streets. The wheelchair accessible spots are only for use with a government handicap sticker.

Responsible Use of TECHNOLOGY

The St. Clair Catholic District School Board's policy addressing expectations for the acceptable use of technology was updated in April 2013. The policy applies to all trustees, administrators, academic and support staff, students, parents, volunteers, visitors and other persons in relation to Board computer equipment, networks as well as personal devices while on Board property or in relation to Board business or Board -related activities. NO CELL PHONES will be allowed outside or during recess/ lunch breaks. Phones will be allowed for educational purposes and only out at the discretion of the teacher. Parents wanting to contact their children are encouraged to do this the old fashion way—call the school and leave a message. Students who are found having their phones out without teacher permission—will then have their phones sit in the office until the end of the day. On the third warning, parents will need to come in and get the phone.

Consent for Release of Student Information

In April 2017, the St. Clair Catholic District School Board adopted a new Social Media and Electronic Communications policy and procedures. The new policy can be found on the Board website at <http://www.st-clair.net/policies.aspx> Look under Section B – Administration.

The new policy has required a new consent form for release of student photographs, videos, classroom work, etc. for various publications, including Board websites or social media sites, school yearbooks, newspapers, television and radio newscasts. You will receive a new consent form this year from the school if you are new to the building. Please sign the form and return it to the school, either granting or withholding consent.

Soy-Based Peanut Butter Substitutes

No peanut or tree nut products in the school.

It is the practice of the St. Clair Catholic District School Board not to permit soy-based peanut butter substitutes in schools, where students are known to have peanut butter allergies. This is a position which has been reviewed with the Medical Officers of Health for Lambton County and Chatham-Kent, and which they support. The Board's Special Education Advisory Committee (SEAC) also supports the Board's position.

The difficulty is this. Although the product itself is perfectly safe, it mimics another product which is deadly for students who are anaphylactic to peanuts. The substitute looks, smells, spreads and tastes like peanut butter (eg. WOW Butter). It's packaged like peanut butter; and, it's sold on grocery store shelves in the peanut butter aisle. Once it's out of the jar, you can't tell the real thing from the substitute and that's what makes it so dangerous for students with nut allergies.

Therefore, St. Clair Catholic will err on the side of caution. In school communities where anaphylaxis to peanut products is an issue and soy-based peanut butter replacements are coming into the school, parents should be advised that the substitutes are not acceptable food items. Parents should also be advised that if the product is sent to school, the child will be provided with a healthy alternative or asked to eat in a location that will ensure there will be no contact with students who are allergic. Parents of students who bring soy-based peanut butter substitutes to school should be reminded of the reasons why it is not an acceptable food item and asked to seek an alternative.



In our Catholic school communities, it is the responsibility of each of us to safeguard the well-being of all of us. We look out for each other. A danger to even one child is a threat that we must all take seriously. Sometimes that means sacrificing what we may perceive as our right in order to meet the needs of another. In instances where a child's life may be at risk, the choice is simple.

Scent Awareness

Recently, the St. Clair Catholic District School Board, in collaboration with our Joint Health & Safety Committee, developed a Scent Awareness Procedural Guideline, to guide staff, students and volunteers in this important area of wellbeing.

Fragrance can have a strong impact on the health and productivity of some individuals. Exposure to strong scents and fragrances in the environment can cause a range of effects, from mild discomfort to triggering an asthma attack, which directly impacts the health of those individuals. The purpose of the new procedural guideline is to promote an environment which supports teaching and learning for all staff, students, volunteers and visitors to our buildings. To that end, the guideline directs individuals to refrain from wearing or using scented products on Board premises and during Board-sanctioned activities.

Scented products include but are not limited to:

Personal hygiene products (e.g., shampoo, conditioner, hairsprays, deodorants, colognes, after-shaves, fragrances, perfumes, lotions, soaps, cosmetics and creams);

Industrial and household chemicals and cleaners;

Air fresheners (e.g., deodorizers, potpourri, oils and candles)

The Board has worked with the public health units in the development of these new procedural guidelines, which have in recent years become common in public spaces. Signage is posted in all St. Clair Catholic buildings.

As always, thank you for your support and cooperation, as together we work to keep as a top priority the health and wellbeing of our staff, students and visitors to our buildings.



Fair Notice Communication Regarding Violence Threat Risk Assessment Protocol

To Parents, Guardians and Caregivers of students in the St. Clair Catholic District School Board

The St. Clair Catholic District School Board is committed to providing safe learning environments for all students, staff, school visitors and community members. When a student behaves inappropriately, principals will most often employ progressive discipline strategies to help a student take responsibility for their actions, learn from their mistakes and make better choices in the future.

In more extreme cases however, when a student's behaviour poses a potential threat to their own or others' well-being, the Community Violence Threat Risk Assessment Protocol (VTRA) supports principals in taking further steps to safeguard everyone.

The VTRA protocol outlines how a school responds immediately to threatening incidents including but not limited to: possession of a weapon or replica weapon, bomb threat or plan, verbal or written (including electronic) threats to harm oneself or others, other threats of violence, and fire setting.

The initial response team is likely to include the Principal / Vice Principal, police and board staff. Should conditions warrant, a Community Threat Assessment Team will be convened. This community team includes representatives of community agencies who work with schools and boards to keep our students and staff safe, such as local police and children's mental health organizations.

Parents and guardians will be notified if their child will be discussed through the Community Violence Threat Risk Assessment Protocol. If parents/guardians cannot be reached, or if they choose not to provide consent, but a concern for safety still exists due to threatening behaviour, the threat assessment may still proceed. Personal information shared throughout this process will respect and balance each individual's right to privacy with the need to ensure the safety of all.

As always, student safety is our first priority. This notification is being provided via avenues such as school newsletters and school and board web sites as fair notice to parents and guardians of the existence of the VTRA Protocol and its application if situations warrant. If you have any questions regarding the St. Clair Catholic District School Board Community Violence Threat Risk Assessment Protocol, please contact your school principal as the first step.

Classroom Organization

Dear Parents/Guardians,

Over the summer, staff at the Catholic Education Centre and in our schools began the work of organizing classrooms for September. As parents/guardians, it is important that you understand and support the role of the principal and Board staff as it relates to classroom organization in your school.

As you may be aware, the Ministry of Education regulates the number of students in classrooms. In elementary schools, class-size caps are set by provincial directive for individual grades; and for a system-wide average that must be maintained across the entire school board. Therefore, the number of classrooms, grades associated with each classroom and the number of students in each classroom in your school must always be viewed from a Board perspective, not just at the school level. It is also important to note that provincial funding is tied to compliance with this regulation. In other words, if we don't meet the Ministry requirements there is a financial penalty which will affect the support provided to our students.

The result of this directive is that combined grades are common in all schools across the province as a means of ensuring that boards are compliant with the provincial regulation. A common perception among parents is that combined grades are detrimental to learning; or, that they are a reflection of students' abilities – that is, in a Grade 2-3 split, the Grade 2s are above average learners and the Grade 3s are below average. The fact is all classrooms include students with a range of skills and abilities. Combined classes are neither better nor worse than single-grade classes. They are simply one of the many ways schools meet students' academic and social development needs.

In addition, a great deal of time and effort goes into decisions at all of our schools, as our staff strives to create a classroom environment that supports the needs of all of all students. These decisions are ultimately made by the principal, in consultation with Board administration and student support staff.

Changes in classroom organization that are created when students move in or out of the school boundary, or by changing student needs from June to the first weeks in September, can create a domino effect that could result in changes to classrooms, which can sometimes impact every grade in the school. Even changes at another school can affect the classroom organization at your school.

It is the Board's goal to make every effort to accommodate these changes with as little disruption as possible. Students changing classrooms are always given a warm welcome by their new teacher and classmates.

Thank you again, for understanding and supporting the efforts of your principal and the school staff, in this important matter. It is our commitment to you that, although we must always strive to meet this provincial regulation, we will do so at all times having regard for the best interests of our students and our staff.
