

## **Healthy Snack Program**

I'd like to introduce the Healthy Snack Program. We are evolving the breakfast program into a healthy snack program provided to all students (for those who wish to participate). The breakfast program will no longer operate before school. The Healthy Snack is prepared by our Educational Assistants in the morning and our Wellness Leadership Team





will deliver to classrooms starting at (9:05 a.m.) The snack program offers a variety of proteins, healthy carbs and healthy fats. All students have access when they enter the classroom at the beginning of the day. The Healthy Snack program assists students maintain their stamina for learning to feed our bodies promoting optimal learning conditions. The snack program will be an additional opportunity (in addition to lunches from home). We thank OSNP and Al Davies for helping to facilitate this program for us. Throughout the year, we hope to access other special grants to complement this program.

## **Warm Welcome Entry**

Starting on Wednesday Sept. 4, students will enter their classrooms when they arrive at the school in the morning. This is called a Warm Welcome Entry. Many schools in our board participate in this beginning of the school day entry. It has many benefits.

The students will not stay outside to wait for the 9:15 a.m. bell as previously done at St. Ursula. Kindergarten students will enter through their regular door where Mrs. Bennet or Mrs. Chickowski will meet them. Adult supervision is in place for both Kindergarten classes. Students in grades 1 &  $\frac{1}{2}$  will enter through the primary doors. Students in  $\frac{2}{3} - 8$  will enter through the intermediate doors. These specific doors will be unlocked at 9:00 a.m. Students will proceed directly to their classrooms.

Teacher supervision is provided, similar to an indoor recess, providing close proximity in designated classrooms of the school. There are 4 teachers on duty for grades 1 -8, rotating among their assigned classrooms. The K classes are supervised by the RECE or an EA in the classroom. Students choosing to arrive before 9:00 a.m. will be waiting outside until 9:00 a.m. Please be reminded supervision does not start until 9:00 a.m. (15 minutes before the instructional day begins). This is why the doors are unlocked at 9:00 a.m. There are many benefits to a Warm Welcome Entry. Some include:

- Learning can begin promptly at 9:15 a.m. which is the beginning of our school day

   instead of lining up at 9:15 a.m. then proceeding to their classroom which takes
   away from learning;
- Students have an opportunity between 9:00 9:15 a.m. to get settled for their day. Educators have established classroom routines. This is ideal to provide structure;
- Students can participate in the healthy snack program upon entering the room;
- For some students arriving shortly after 9:00 it can be quieter in the school and/or classroom which some find reduces anxiety;
- When agreed upon, students can arrange to meet teachers for extra help when the teacher is available.

### **Home & School Communication, EDSBY??**

After this month, all school communications including newsletter will be sent to you through email via the CASL email system. Please ensure that your email address is up to date with the school office. A paper copy of the monthly calendar will continue to come home in paper form for you to hang on the fridge!

Students from K – Gr. 6 will have notebooks where communication between home and school is recorded and school items. Students in grade 7 & 8 will use electronic means of keeping organized –to be negotiated between the students and their teacher OR they can purchase their own agenda of choice. All classroom teachers will send home instructions for EDSBY. Or other form of communication. The night of the Open House there will be an opportunity to get assistance to sign up if needed. I strongly encourage parents to sign up for the opportunities provided. The St. Ursula Family Handbook includes information from the board level and will be sent home via CASL email during the second week of September.

# Keeping Our Schools Safe

The St. Clair Catholic District School Board has installed remotely controlled door locking systems, including cameras and intercoms, at all elementary schools. Parents and visitors are required to identify themselves at the door and sign in at the office as they enter the building. It is important to note that there may be times when our school secretary will be away from her desk for a moment and visitors may have to wait. Alternatively, parents and visitors should consider the following:

- 1. Call and let us know when you are coming.
- 2. Let us know if you want to pick your child up so that we can arrange to have him/her ready for you. Ideally, send a note to your child's teacher.

# **Consent for Release of Student Information**

In April 2017, the St. Clair Catholic District School Board adopted a new Social Media and Electronic Communications policy and procedures. The new policy can be found on the Board website at <a href="http://www.st-clair.net/policies.aspx">http://www.st-clair.net/policies.aspx</a> Go to Section B – Administration.

Under the policy, signed parental consent is required for release of student photographs, videos, classroom work, etc. for various publications, including Board websites or social media sites, newspapers, television and radio newscasts.

Once consent is obtained, it remains in effect for the student's entire school career. However, if at any time for any reason parents/guardians wish to revoke consent, you are asked to please contact the school.

### Health Canada Advisory Regarding Drawstrings for Children's Upper Outerwear

Health Canada advises that some children's clothing products can pose a danger. The products listed as potential hazards for children include upper outerwear in sizes newborn to 12 years that have drawstrings in the hood and neck area.

"Children's upper outerwear" means upper body clothing, such as jackets and sweatshirts, generally intended to be worn over clothing. Drawstrings on these garments can become caught on playground equipment, fences or other objects and result in strangulation; or, in the case of a vehicle, a child being dragged. Parents should ensure that purchases of children's clothing have alternative closures to drawstrings, including elastics, buttons, vecro or snaps.

## **Soy-Based Peanut Butter Substitutes**

It is the practice of the St. Clair Catholic District School Board not to permit soy-based peanut butter substitutes in schools, where students are known to have peanut butter allergies. This is a position which has been reviewed with the Medical Officers of Health for Lambton County and Chatham-Kent, and which they support. The Board's Special Education Advisory Committee (SEAC) also supports the Board's position.

The difficulty is this. Although the product itself is perfectly safe, it mimics another product which is deadly for students who are anaphylactic to peanuts. The substitute looks, smells, spreads and tastes like peanut butter. It's packaged like peanut butter; and, it's sold on grocery store shelves in the peanut butter aisle. Once it's out of the jar, you can't tell the real thing from the substitute and that's what makes it so dangerous for students with nut allergies.

Therefore, St. Clair Catholic will err on the side of caution. In school communities where anaphylaxis to peanut products is an issue and soy-based peanut butter replacements are coming into the school, parents should be advised that the substitutes are not acceptable food items. Parents should also be advised that if the product is sent to school, the child will be provided with a healthy alternative or asked to eat in a location that will ensure there





will be no contact with students who are allergic. Parents of students who bring soy-based peanut butter substitutes to school should be reminded of the reasons why it is not an acceptable food item and asked to seek an alternative.

In our Catholic school communities, it is the responsibility of each of us to safeguard the well-being of all of us. We look out for each other. A danger to even one child is a threat that we must all take seriously. Sometimes that means sacrificing what we may perceive as our right in order to meet the needs of another. In instances where a child's life may be at risk, the choice is simple.

### **Scent Awareness**

Recently, the St. Clair Catholic District School Board, in collaboration with our Joint Health & Safety Committee, developed a Scent Awareness Procedural Guideline, to guide staff, students and volunteers in this important area of wellbeing.

Fragrance can have a strong impact on the health and productivity of some individuals. Exposure to strong scents and fragrances in the environment can cause a range of effects, from mild discomfort to triggering an asthma attack, which directly impacts the health of those individuals. The purpose of the new procedural guideline is to promote an environment which supports teaching and learning for all staff, students, volunteers and visitors to our buildings. To that end, the guideline directs individuals to refrain from wearing or using scented products on Board premises and during Board-sanctioned activities.

Scented products include but are not limited to:

- Personal hygiene products (e.g., shampoo, conditioner, hairsprays, deodorants, colognes, aftershaves, fragrances, perfumes, lotions, soaps, cosmetics and creams);
- Industrial and household chemicals and cleaners:
- Air fresheners (e.g., deodorizers, potpourri, oils and candles)

The Board has worked with the public health units in the development of these new procedural guidelines, which have in recent years become common in public spaces. Signage is posted in all St. Clair Catholic buildings. As always, thank you for your support and cooperation, as together we work to keep as a top priority the health and wellbeing of our staff, students and visitors to our buildings.

### Food Days & Milk

The milk and food day program will begin on Monday, September 30<sup>th</sup> Both chocolate and white milk will be available to purchase for the month. Pizza will be every Tuesday. As well as we exploring other vendors that meet the Food & Beverage Policy to offer more opportunities to provide variety for lunch while raising funds for student activities and excursions. All profits are used for student activities & services (i.e. subsidized bussing costs for special events, outdoor play equipment, classroom materials, etc.). All food and milk orders will be posted to School Cash Online for your convenience. Watch your email for notifications! CSAC will continue to sponsor food days throughout the year as well.
