#### **Defining the Issues**

### Demographics & Facilities - Jim McKenzie, Associate Director - Corporate Services and Treasurer

- Sarnia Secondary ARC: A Review of Key Points from the November 18<sup>th</sup> Presentation available on the website Report
  - Questions from ARC members
    - Question Ms. Hayter Was the St. Patrick's property purchased from LKDSB or leased?
    - **Response** Mr. McKenzie The former Lambton County Roman Catholic Separate School Board purchased the property under the terms of the day, which meant title was transferred for one dollar. Today, when we wish to sell property, we are permitted to ask full market value.
    - Question Mr. Kardas Is the government top up funding guaranteed?
    - Response Mr. McKenzie Yes, but we have to remove unused classroom space from the calculations, which results in changes to school capacity and, in turn, affects the funding received.
    - **Question** Ms. Beauregard Why is there a discrepancy in the cost of the water between St. Christopher and St. Patrick's?
    - Response Mr. McKenzie The discrepancy may be due to the use of the fields at St. Christopher in the summer. I will have to investigate this further and will post the answer to the website.

Follow-up Response - Mr. McKenzie

There is a substantial variance in water usage and cost during the months of July, August and September between the two schools, which can be attributed to field watering at St. Christopher. The area being watered at St. Christopher is approximately twice the size of that at St. Patrick's. St. Christopher has both a football field and a soccer field (inside the track), while St. Patrick's only has a football field. In addition, St. Christopher put in a new natural garden this past year, which was heavily watered during the summer. With the exception of the three months noted above, water usage and the related costs at St. Patrick's exceed those of St. Christopher during every other month of the year.

- Question Ms. Etienne Is it correct that if we cannot meet the needs of students with an IEP in our high schools it would be suggested that they should attend a public high school to have their needs better met?
- **Response** Ms. Courey We can accommodate every student in every one of our secondary schools.
  - Mrs. Gray We make a place for every student from grade 9 to 12, considering all needs. This is done on an individual basis. We would never recommend that any student attend a public school.
  - Mr. Deery When a parent comes with a student who has an IEP we make every effort to ensure that the needs of the student are met from grade 9 to 12. We have a very inclusive system and we make every effort to accommodate every student within our schools and to develop a pathway for them from grade 9 to 12.
  - Ms. Sutton The model for our Catholic schools is one of inclusion and not segregation, as we are all valued members of the Body of Christ.
- Question Fr. Bedard Who makes the decision as to which courses are offered?
- Response Ms. Courey The school the administration, in consultation with board administration, based on student and community needs.
- Question Mr. Kardas When there is a larger school, such as UCC, are there any issues regarding class size?
- **Response** Ms. Courey No, classes are no larger than at any other school. In addition, when there is low enrolment for a course, it would not be viable to offer it; however, this is less likely to happen in a larger school.
  - Karen Dolson, Coordinator of Planning Services Average class size is mandated by the Ministry of Education regardless of the size of the school. The average class size is the same at all of our schools.
- Question Mr. Kardas What is the average class size?
- Response Ms. Dolson It may be 21 or 22 but this will have to be confirmed and will be posted on our website.

Follow-up Response - Ms. Dolson

Maximum average class size for secondary schools is 22. In a larger school, where more sections of the same course are offered, there is more flexibility to divide the students amongst several classes to lower class sizes.

- Question Fr. Bedard If there is a course which is important for the student's education and is not offered at the student's home school and not offered as a magnet course, can a student change schools to take the course?
- **Response** Ms. Courey It may be handled by an e-Learning course.
  - Mr. Deery Beginning next semester, we have two students who are going to be taking courses in both schools, as there is a course being offered at one Catholic high school, but not the other. When the course is offered as part of the magnet school program, transportation is provided. If the course is not a magnet school program course, it is up to the student to provide their own transportation between schools.

# 8:15 p.m. Discussing the Options Facilitated by Mr. Galloway

- Focus Group Summary Presentation available on the website Report
- Questions from ARC members
  - Question Ms. Etienne How were focus groups selected?
  - **Response** Mr. Galloway An open invitation to students, parents, and teachers was issued and then a request for volunteers was issued. If more people were still required, individual invitations were made to ensure a good mix of gender and age was achieved.
  - Question Ms. Chynces What was the purpose of the focus groups?
  - **Response** Ms. Sutton Focus groups were to gather information and perception from a very large group of constituents in our community and to help inform the ARC about possible alternatives.
  - **Question** Fr. Bedard Are there actually two unique cultures which, when integrated, would cause great anxiety?
  - **Response** Mr. Galloway St. Christopher is seen as a "preppy school" with fewer socio-economic issues. It has a more homogenous culture. The St. Patrick's community is perceived as having more socio-economic and family challenges and greater cultural diversity.
  - Question Fr. Bedard Do the principals see the same diversity within the students of their schools?
  - **Response** Mr. Deery The key aspect is one of perception. Students compete between the schools but they also do things together. Students do integrate with each other outside of the school.
    - Ms. Gray The perception is there, but the magnet program has solidified the knowledge that students of both schools can come together and it has also shown that the students feel at home regardless of which school they attend.
  - Question Ms. Hayter Would we consider polling our students in grades 7 and 8 concerning bussing?
  - **Response** Ms. Sutton Surveys have been done in the past. As this process continues, the ARC may ask for specific reports from the board, which may help you to make your final decision.
  - Question Ms. Hayter Are the boundaries for Sacred Heart, Port Lambton and St. Joseph, Corunna open meaning that students are able to choose which Sarnia Catholic secondary school they wish to attend and is this a reason for the decline in enrollment at St. Patrick's?
  - **Response** Ms. Dolson Students from St. Joseph, Corunna may choose which Sarnia Catholic secondary school they wish to attend. Students from Sacred Heart, Port Lambton are within the boundary area for St. Patrick's. There is a process within our board where a parent may make application for a student to attend a school outside of their boundary area. This application goes to both school principals and finally to the superintendent. Decisions are made on an individual basis. If granted, the parents must provide transportation.
  - Question Ms. Hayter Why and when was the boundary changed for St. Joseph, Corunna?
  - **Response**: Ms. Dolson The date when this changed occurred will have to be checked into and will be posted on the website. It may possibly have happened in about 2002.

Follow-up Response - Ms. Dolson

At the Regular Board Meeting of Tuesday, February 11, 2003 the following motion was made with regard to St. Joseph Catholic School, Corunna, to address the declining enrolment of north secondary schools:

Motion: O-042-2003 (Linda Ward and Bill Sparks) That the St. Clair Catholic District School Board designate St. Joseph School, Corunna as a feeder school for St. Christopher Catholic Secondary School, with proviso that parents may select St. Patrick High School if that is preferable for their family.

- Question Ms. Hayter There has been a report of aggressive recruiting of elementary students from high school coaches from outside our board and from St. Christopher, to get students to attend a school outside of their boundary area.
- Response Mr. Deery The expectation we have is that elementary students attend the high school to which they are partnered and that there is no recruiting of students by coaches from St. Christopher.
   Ms. Sutton Recruiting from outside of our school board is not supposed to happen; however, we do hear from time to time that it has occurred. On these occasions, our Superintendent would contact a Superintendent from our co-terminus board to inform them of this issue, and vice versa.
- Question Mr. Kardas One of the draw backs to the consolidated school model seems to be the loss of students to another board. Is it possible to contact another board which has already gone through this process to see if this was the case and how it was addressed?
- **Response** Mr. Galloway In two cases in Kitchener it made no difference in the student enrolment. We may want to contact the Guelph board to see what happened there.

Follow-up Response – Ms. Dolson

I have contacted the Wellington Catholic District School Board. Bishop McDonnell School was closed back in 1995 and enrolment statistics for the number of students who transferred to the public board at that time are not available.

- Question Ms. Hayter In the focus groups, was a rebuild of St. Patrick's high school discussed?
- **Response** Mr. Galloway It was the opinion of some focus group participants that to invest eight million dollars into the school was not a viable option due to the age of the building.
- Question Ms. Etienne What is maximum bus ride time allowable?
- **Response** Ms. Sutton The question will need to be answered by Kent Orr, Manager, Transportation Services and the response will be posted on the website.

Follow-up Response - Mr. Orr

The Conditions of Service portion of the Transportation Policy (available on the <a href="https://www.schoolbusinfo.com">www.schoolbusinfo.com</a> website under the Policy section) states the following, regarding maximum allowable ride times:

- 1. Riding Time
  - 1. Other than in exceptional circumstances, students in elementary school will not spend more than 60 minutes on the bus, one way, each day.

2. Other than in exceptional circumstances, students in secondary school will not spend more than 75 minutes on the bus, one way, each day.

The longest rides currently are for two students, who each have 67 minute ride times at either the start or the end of the school day.

- Question Ms. Etienne Can boundaries for high schools be changed?
- Response Ms. Dolson Boundaries for any of our schools can be reviewed and changed.
- **Question** Ms. Etienne Would the board consider a subsidized transit pass as a substitute to school bussing?
- **Response** Ms. Sutton This question will need to be directed to either Mr. McKenzie or Mr. Orr to respond to on the website.

Follow-up Response – Mr. Orr

Currently, the transportation consortium does not utilize local transit as part of the home-to-school transportation of students. The transportation routing solution currently employed incorporates an intentional mix of contracted school buses and multi-tiered, integrated routes that are scheduled for maximum efficiencies and conditions of service as outlined in the transportation policy. Transit routes and cost effectiveness would need to be reviewed and compared to available school bus alternatives.

- Question Ms. Etienne How much incidental use of St. Patrick's school occurs due to use of the track facilities?
- Response Bruce Hannah, Manager, Facility Services I don't have specific information about incidental use of our school facility as a result of track usage. However, I can tell you that there is a three party agreement for the track, which is managed by Mr. McKenzie and his counterpart at our co-terminus board.
   Bernadette Gray Whenever the track is used by anyone, the school is also used i.e. washroom facilities, cafeteria, etc.
- Ms. Sutton This question will be directed to Mr. McKenzie and the answer will be posted on the website. Follow-up Response – Mr. McKenzie

I have no further information, as we are not required by the Ministry of Education to capture this type of data related to community use of our facilities.

- Question Ms. Chynces What is our next step as members of the ARC?
- **Response** Ms. Sutton The next step will be to discuss the options.
- Question Ms. Beauregard How long were the focus group discussions and how many participants were there?
- **Response** Mr. Galloway The lengths of the discussions varied, usually from 50 minutes to an hour and ten minutes. The size of the groups varied from 4 to 18 participants.
- **Question** Ms. Etienne Can the ARC be provided with a summary of programs which are considered essential regardless of which option is chosen by the ARC?
- Response Ms. Sutton Ms. Courey will prepare such a report for next meeting.
- Question Mr. Kardas Is it this committee's responsibility to recommend how the changes in our



	recommendation are to be implemented?
	<ul> <li>Response – Ms. Sutton – That is not your responsibility; however, you may wish to make suggestions on how your recommendations are to be implemented. Your recommendations will be taken by the Director of Education to the Board of Trustees at a public board meeting. The trustees will also receive a recommendation from the Director of Education. It is the Board of Trustees who will make the final decision They may decide to take either recommendation as originally drafted; or, they may make some amendment to the recommendations; or, they may settle on a decision that was not part of either recommendation. It is the responsibility of senior administration to implement the decision of the Board of Trustees.</li> </ul>

#### Questions from the floor

Question – Would it be financially feasible to build a smaller secondary school in the south end of Sarnia?

**Response** – Ms. Sutton – This question will be directed to Mr. McKenzie, for a response to be posted on the website.

Follow-up Response – Mr. McKenzie

Unable to answer this question, as there are too many variables and decisions that would have to be made related to the size of the facility, programming requirements, etc. Generally speaking, if a decision was made to keep a secondary school in the south end of Sarnia, major renovations to the existing structure would be less costly than the demolition of the existing school and the building of a completely new secondary school to replace it.

**Question** – In the St. Clair Catholic District School Board's history, when we have closed schools do we know how many students have left our board to attend schools of our co-terminus board i.e. St. Helen's closure?

**Response** – Ms. Dolson – The numbers are not available tonight. They will be posted on our website.

Follow-up Response – Ms. Dolson

Transfers to and from Catholic schools and public schools:

2006-2007 – 144 students transferred from public schools to Catholic schools; 112 students transferred from Catholic to public schools

2007-2008 – 90 students transferred from public schools to Catholic schools; 37 students transferred from Catholic to public schools

Transfers from Catholic schools to public schools following school closures are as follows:

Our Lady of Help, Wallaceburg (July 1, 2000) – 4 students to public school

Our Lady of Mercy, Sarnia (July 1, 2001) – 5 students to home school; 3 students to public school Fr. Gerald Labelle, Corunna (July 1, 2001) – 2 students to public school; 12 students moved out of Corunna

St. Ambrose, Chatham (July 1, 2001) – 2 students to Chatham Christian School; 2 students to public school

Blessed Sacrament, Chatham (July 1, 2002) – 2 students to public school

St. Joseph, Sarnia (July 1, 2002) – 22 students to public school (January 2002); 6 students transferred back to St. Therese in September.

St. Helen, Sarnia (July 1, 2003) – 63 students to public school; 3 families transferred back after 1 year St. Ignatius, Bothwell (July 1, 2005) – 38 students to public school

Question – What is the retention rate for Catholic students as they transition from elementary to secondary school?
