Background

A memorandum was issued to all Directors of Education from the Ministry of Education on April 5, 2011 titled, <u>Instructions Regarding School Boards'/ School Authorities' Reports on the Provision of Special Education Programs and Services, 2011</u>. This memorandum advised that Boards would not be required to submit a special education plan to the Ministry. However, Boards are required to ensure that a report is available to our community regarding the special education programs and services available to meet the needs of the students in our board. School boards are required to review the report and update it by making any necessary additions and/or amendments to relevant sections. In preparing or updating this report, school boards and school authorities must continue to consult with their respective Special Education Advisory Committees (SEAC) as per *Regulation 464/97*.

Each school board must ensure that this information is made available to all members of the board community by the start of each school year. School boards are strongly encouraged to post the special education reports in a user-friendly format on their public websites.

A comprehensive report on special education programs and services should include the components that are defined in *Standards for School Boards' Special Education Plans* (2000) as well as the protocols established in PPM 149.

This year, boards are required to submit a copy of a completed checklist signed by the Director of Education, including board website link, to the regional office by July 31, 2021.





Highlights

The St. Clair Catholic District School Board's Special Education Report 2021 is prefaced with the Board Special Education Report Status of 2020.

The Ministry checklist outlining the components that must be included in the Special Education Report was utilized to ensure compliance by the St. Clair Catholic District School Board.
