PART A - GENERAL

1.1 BID CLOSE EXTENTION

All general contractors please be advised that the bid close date has been postponed to 2:00pm Thursday May 10th, 2018. Please refer to attached revised bid form and attached instructions to bidders.

1.2 QUESTIONS:

a. <u>Question</u>: Can you provide us details (5 - A050) above block, stud, insulation and drywall framing. How many linear feet are like that?

<u>Answer</u>: The locations where walls are required to have a fire rating, and thus will be constructed as illustrated in detail 5/A050, are as follows:

- 1. The new IW3.3 wall (2.3 lin meters) between the mechanical addition 150B and the new universal washroom 152. This will have a 1-hour fire rating.
- 2. The new wall IW2.1 (6.4 lin meters) and IW3.1 (2.9 lin meters) making up the new custodian room 144. These walls will have a 45-minute fire separation.
- 3. The new wall IW2.2 (2.2 lin meters) separating new storage room 120 and the new staff washroom 119. This wall will have a 45-minute fire separation.

Consult the Life safety plan on A010 for all fire separation requirements, and the wall assemblies on A050.

b. <u>Question</u>: Please advise where details 4 and 5 on drawing A050 are located within the drawings?

<u>Answer</u>: Detail 4/A050 occurs at each masonry control joint along the exterior walls. Detail 5/A050 occurs at locations listed in the previous question (a).

c. <u>Question:</u> In the wall descriptions it calls for Blueskin and spray foam. Is Blueskin required behind the spray foam?

Answer: Yes, Blueskin is required behind the spray foam.

d. Question: Under the overhangs at the entrances/exits, it calls for T&G Oak. Is this a wood product or metal product? Could not locate in the specifications.

Answer: This product is clear 3/4" oak stained natural.

e. Question: Will there be an extension?

<u>Answer:</u> Yes, the closing date for bid submission has been moved to 2:00pm Thursday May 10th 2018.

f. <u>Question:</u> Please clarify whether the supply and install of power door operator equipment and door control accessories required for the Universal Washroom is to be carried in the Cash Allowance for Door Hardware or to be carried by the GC?

<u>Answer:</u> The supply and install of power door operator equipment and door control accessories for the Universal Washroom is to be carried in the Door Hardware cash allowance.

g. Question: Can we substitute the S.S. Helifix anchors with Blok-Lok S.S. BL 407 rap anchors. If not, please specify which type of Helifix anchor is suitable.

<u>Answer:</u> Blok-Lok S.S. BL 407 rap anchors can be used, but it must incorporate a non-corroding fastener.
