#### ADDENDUM #01

#### A1. SECTION 6. BID INELIGIBILITY

Bids that fail to include the security deposit, consent of surety may, at the discretion of the Owner, be declared informal.

#### **Revised to:**

Bids that fail to include the tender security and/or bonding as outlined in 14. BONDING may, at the discretion of the Owner, be declared informal.

#### A2. SECTION 14. BONDING

On bids exceeding \$ 100,000.00, submit with the Bid an Agreement to Bond for a 50% Performance Bond, and a 50% Labour & Material Payment Bond. Upon request, the successful Bidder will be required to provide the 50% Performance Bond and 50% Labour and Material Payment Bond from a bonding company acceptable to the Board. The cost of the bond is included in the bid sum, the amount of which is to be identified on the Bid Form.

#### **Revised to:**

On bids exceeding \$100,000.00 (inclusive of all taxes) the following tender security / bonding is required and must accompany the bid:

- Agreement to Bond: 50% Performance
- Agreement to Bond: 50% Labour and Material Payment Bond
- Bid Bond: 10% of the bid price, payable to the St. Clair Catholic District School Board

Only bond and agreements to bond issued by a licenced Canadian surety company authorized to do business in the Province of Ontario will be accepted. Upon request, the successful Bidder will be required to present the bonds to the Purchasing Department. Failure to provide the proper surety to the Board upon award will result in rejection of that Bid. The cost of bonding shall be included in the Bid price and identified on the Tender Form.

- A3. SCOPE OF WORK: All bidders are to include in their base bid price the supply and installation of primer on the existing metal roof deck prior to installing the vapour retarder from the proposed membrane manufacturers within the technical specification.
- A4. CLARIFICATION FROM SITE VISIT: existing rigid insulation system was confirmed to be mechanically attached through the metal roof deck with fasteners. All fasteners are required to be removed prior to the installation of the new proposed roof system

#### A5. Responses to questions received.

**A6. REVISED TENDER FORM.** The attached REVISED TENDER FORM document supersede the bid documents originally issued on March 6, 2019. Separate Pricing 'A' & 'B' were added to identify the cost of tarping the gymnasium floor and the potential cost savings of not installing of fiber cant strip around the roof perimeter. REVISED TENDER FORM <u>must</u> be used at the time of submission.

#### A7. DRAWING R2 is enclosed with this addendum.

#### **QUESTIONS AND ANSWERS**

- Q1: In the above noted project, we seem to be missing Drawing R2 in the tender documents. Please advise.
- Answer: Refer to the enclosed Drawing R2.



- Q2: Is the roofing contractor to responsible for any mechnical work that might need to be done on the roof? If So do you have a contact for a mechnical contractor who services the unit and is firmilar with the builing?
- Answer: The roofing contractor will <u>not</u> be responsible for the disconnection, removal and re-installation of the condensate unit. The Board will disconnect the newly installed condensing unit on roof area 'C', just west of roof area 'B' (north of stage area of gymnasium) to allow the successful roofing contractor to remove and replace the roofing system beneath the existing condensing unit. Once the new roofing system is completed, the board will look after re-installing the condensing unit in its original location.
- Q3: Drawing R-2 Seems to be missing from the tender package can you please include the drawing?
- Answer: Refer to the enclosed Drawing R2.
- Q4: Is the canopy south side of the building consider roof area A? and the adjacent roof being roof area B?
- Answer: Drawing R2 clarifies what is considered to be areas A and B.
- Q5: Is interior tarping required for the inside of the building?
- Answer: Interior tarping is only required in the gymnasium, to protect the newly installed athletic floor. Refer to the revised tender form Separate Price 'A'. No other areas within the school require interior tarping.
- **Q6:** I notice on Option 2 Soprema you have spec Bakor items. Is it possible to revise the spec with the proper Soprema products?
- Answer: The tender specification only refers to Bakor in item 6.19 Plastic Roof Cement. Under this item number, the document clearly states this product can be Bakor or approved equal. Successful roofing contractor can use the Soprema equal.


