The following items shall amend and supersede the Tender Documents issued February 5<sup>th</sup>, 2018.

- 1. Enclosed is a Revised Tender Form which shall be used by the Contractors that now includes a space for the Allowance to have the Engineered Air MUA Unit disconnected, then lifted off the roof to allow for the Roofing Contractor to supply and install a new wooden platform prior to commencing with the new roof system, then lift the Unit on top of the new platform and reconnect to ductwork, gas line, electrical, etc.
- 2. In regards to the question regarding Tapered Insulation, the Contractor is to include the cost for all Tapered Polyiso Rigid Insulation for <u>sumps and backslope</u> in their <u>Total Tender Price</u> cost. The Contractor is also required to provide a <u>Separate Price</u> to supply and install the <u>Tapered</u> <u>Backslope Insulation</u> only as indicated on Drawing UCC-R3a.

The Contractor is also required to provide a <u>Separate Price</u> to supply and install the <u>Tapered</u> <u>Cricket Insulation</u> only as indicated on Drawing UCC-R4a.
- **2.** In regards to the Two-Ply Modified Bitumen Roof System on Roof Area 'K', the following changes are to be noted:
  - Insulation to be as specified
  - With Soprasmart Board 180 on top or approved equivalent
  - With Sopraflash Flam Stick over top roof perimeters and metal drip edge and gravel stops or approved equivalent
  - With Sopralene Flam 250 GR Cap Sheet torch applied to the Soprasmart Board or approved equivalent.
