- 4. QUESTION: Are there any backflow devices at any schools required to be tested?

- 5. QUESTION: Do any schools have fire pumps that are required to be included?
- ANSWER: No fire pumps
- 6. QUESTION: If no Inspection Sheets are provided can you clarify the number of sprinkler risers at each sprinklered schools?

7. QUESTION: First, are we able to get onto the vendor list in order to submit a price?

ANSWER: Submissions will be accepted from all bidders. Section 5.10 in the tender document explains process for awarded bidder.

8. QUESTION: Are we able to receive either last years FA inspection reports or FA device lists for the schools?

9. QUESTION: Are fire alarm documents (CAN/ULC) reports available for review prior to submitting our bid? Or would the board be able to provide us with a rough approximation of number of fire alarm devices (and emergency lights) in each school for the purposes of properly allotting enough time and accurate value to each school?

10. QUESTION: Response times; The tender notes that response times will be determined by the school board for service calls. Is there an estimate for service call response times or is there a minimum time that service calls need to be addressed or rectified?

ANSWER: Emergency response time minimum 4 hours to be addressed. Non-emergency response times 24 hours to be addressed.
