QUESTIONS (Q) AND ANSWERS (A)

- Q 1. Where are the toggle switches that need to be replaced to keyed switches located on the drawings.
- A 1. The switches for the corridor lighting are to be replaced with the keyed switches. They are located at the ends of the corridors. They have not been shown on the set of drawings provided. Specific details will be provided to the successful bidder.
- Q 2. Which exit signs are to be replaced to LED. They are not marked on the drawings.
- A2. Exit signs that are either Incandescent or Compact Fluorescent are being replaced with the new LED exit signs. These have not been shown on the set of drawings provided. Specific details as to the corridor or room location will be provided to the successful bidder. Refer to Appendix B for the quantities in each school to be replaced and to price the job.
- Q3. Type V2 to V2 has two different voltages listed.
- A3. The retrofit description of Type V2 to V2 in Appendix C describes the 2 lamp ballast required as 347. This is incorrect and the reference should be 120v. The major component referencing the ballast to use is correct as well as the description and quantity in Appendix B. Use the information in Appendix B to price the job.
