Scope of Work

Project consists of the following work, to be awarded as a single contract: Renovations:

Demolish existing walls as indicated. Strip back existing floor finishes as indicated. Provide floor patch and levelling. Break open existing slab on grade for structural and plumbing requirements. Provide engineered temporary structural support (pinning) of building structure to allow for the installation of new structural support at enlarged openings as indicated. Provide plumbing services and electrical services as noted. Finish slab on grade where work has been completed. Construct new exterior walls complete with window & door assemblies as indicated, interior walls, complete with new hollow metal frames and wood doors. Install new flooring as indicated. Patch and repair all damaged walls and ceilings, completely finish and paint all rooms. Install new LAT ceiling as indicated. Provide all millwork and cabinetry as indicated. Addition:

Provide a new one classroom addition and corridor extension as shown on drawings. Work shall generally include excavation for new foundations, foundation walls, slab on grade, new concrete block walls, wood roof truss & 2 ply Modified Bitumen roof membrane assembly. Work will include new exterior facing, windows & doors and required tie-in to existing building as indicated. Interior to have completed flooring, wall finishes and paint. Install new mechanical system, electrical and lighting. Install new LAT ceiling and finish millwork and cabinetry as indicated.

Site work to include backfill, new asphalt where indicated and landscape repair. Phasing:

The Scope of work will include the construction of barriers and hording to allow for phased work.
