# **Contract**

The contract will be CCDC-2008 modified with Supplementary Conditions which are part of the bid package.

## **Bid Security and Performance Assurance**

All Bidders shall provide a 10% Bid Bond and an Agreement to Bond at time of bidding. All Labour and Material Payment Bond and a Performance Bond, each in the amount of 50% of the **Total Contract Amount** is required from the successful Bidder.

## **Insurance**

At time of Bid Closing, provide a signed standard form provided by the Contractor's Insurance Co. or broker stating its intention to provide insurance to the Bidder in accordance with the insurance requirements CCDC2-2008.

## <u>WSIB</u>

At time of Bid Closing, provide a certificate of good standing from the Workplace Safety and Insurance Board.
