2. PRESENTATIONS

A Life Skills at UCC

Jennifer Morrow & Liz Hashim

- Liz Hashim, teacher in the life skills classroom at UCC, participated in a TLLP (Teacher Learning and Leadership Project) 3 years ago which brought a smartboard and 4 iPads into the life skills classroom. These devices were to be used as communication tools, educational tools and sensory tools. The focus of this presentation was on how the iPads effectively assist non-verbal students in developing their communication skills. The class consisted of 11 students who are all mostly non-verbal. Three of the students used their own iPads and the other iPads were either purchased by the life skills program or came from the TLLP project.
- The video clips demonstrated the students working on their social communication skills. The goal of one particular activity was to have students learn to identify personal information through the app Proloquo2go on their iPads and to be able to share that information when meeting people or hanging out with friends. They were also learning how to navigate within the app and practice how to physically manipulate the iPad.
- Other video clips demonstrated the students working at a teaching table (individualized, one-on-one instruction), as well students working at independent work stations.
