ARC Recommendation to the Board

Presentation of the contents

- A copy of the report was distributed to all ARC members for their review.
- The Chair summarized the report to the ARC and drew their attention to the summary of key information, which outlined the capacity, enrolment, number of classrooms, age of the buildings and boundaries of both schools.

ARC Questions on the Recommendation

QUESTION: Would any of our south Sarnia school students go to any of the north Sarnia schools with the

recommended boundary change? In a previous meeting it was thought that no students from south Sarnia schools would be going to north Sarnia schools and this would include families from Heritage Park. If the boundary change means these students will have to attend a north Sarnia school will

these families be granted a boundary exemption to remain at St. Benedict school?

ANSWER: There will be 13 students on the east side of Modeland Road who would be going to St. Anne's school with the

proposed boundary change.

QUESTION: Can we add "new schools or new buildings" somewhere in the recommendation?

ANSWER: Page 3 of the report states "new schools". The entire report forms the ARC's recommendation to the Board. (*Note – The final wording on the recommendation, which will go to the Board of Trustees, has been altered slightly to

accommodate this request and to clarify the boundaries.)
